## Frequently Asked Questions

### ***Do our Chamber dues pay for this?***

No. By law, our association cannot contribute for you. Business leaders must make all political contributions personally and voluntarily. It's really up to you.

### ***Who decides which candidates should receive ChamberPAC support?***

Business leaders like you, members of the ChamberPAC Board of Directors, make the final decision on candidate contributions. The Board considers recommendations from PA Chamber members and the PA Chamber Government Relations staff.

### ***Does any part of my contribution go toward the administration of ChamberPAC?***

No. Every single dollar contributed to ChamberPAC goes directly to candidates — not one penny is used to pay administrative expenses.

### **Contribution Guidelines—these amounts are only a suggestion. All contributions are voluntary.**

Executive CEOs and Presidents	\$2,000 – \$4,000
Senior Officers and Vice Presidents	\$1,000 – \$2,000
Assistant Vice Presidents	\$500 – \$1,000
Managers	\$200 - \$500
Administrative Staff	\$10 - \$200
