Dear Administrator Brooks-LaSure:

I write on behalf of the Pennsylvania Chamber of Business and Industry (PA Chamber) regarding the CY 2024 Advance Notice for Medicare Advantage (MA). The PA Chamber is the largest board-based business association in Pennsylvania. Our nearly 10,000 members include employers across all industry sectors and all sizes throughout the Commonwealth. We appreciate the opportunity to submit these comments.

Health care policy is a key focus for the PA Chamber and our member-driven <u>Health Care Policy</u> <u>position statement</u> recognizes the ongoing struggle to manage the cost and complexity of health care coverage while striving to maintain high standards of quality and accessibility. As the policy states: "Balancing cost, quality and accessibility within the health care system remains a challenge for all stakeholders in the process, including government, insurers, providers, purchasers and consumers."

Medicare Advantage was established to help stakeholders address this challenge by establishing a public-private partnership to expand and improve delivery of benefits and enhance efficiencies. Various types of MA stakeholders are part of the PA Chamber membership, including commercial health insurance carriers and employers who offer Employer Group Waiver Plans (EGWP).

More than 1.3 million Pennsylvanians – nearly half of all those eligible – have chosen Medicare advantage for their health care.¹ The program's popularity in Pennsylvania is attributable in part to the considerable savings that Medicare Advantage beneficiaries enjoy relative to traditional Medicare beneficiaries.²

Proposals put forward in the Advance Notice may put this popular option out of reach for many in our state and could increase costs to employers who utilize EGWP to maintain their commitment of post-retirement benefits to their employees. According to a new study, the Advance Notice may increase premiums or reduce benefits by an average of \$540 per year per member.³ These costs would be significant for many Pennsylvanians living on fixed incomes who depend on Medicare Advantage and for employers who participate in EGWP.
