Speakers



Karen Harbert, President and CEO, American Gas Association

Karen Alderman Harbert is president and chief executive officer of the American Gas Association. Founded in 1918, AGA represents more than 200 local energy utility companies that deliver natural gas to 187 million Americans nationwide.

Prior to joining AGA, she was president and chief executive officer of the U.S. Chamber of Commerce's Global Energy Institute (Energy Institute). Under Harbert's leadership, the Energy Institute evolved into a premier national and international organization dedicated to advancing a constructive energy agenda with the business community, policymakers and consumers. Harbert led the Energy Institute's development of its comprehensive Energy Works for US platform, which provides policy recommendations to secure our nation's energy future and create millions of jobs, billions of dollars in revenue, and trillions of dollars of private investment. Under Harbert's leadership, the Energy Institute established the groundbreaking Index of Energy Security Risk and the International Index of Energy Security Risk, the first tools to quantify America's energy security on an annual basis. Harbert frequently testifies in front of Congress and provides analysis to the media, policymakers, and industry leaders.

She currently serves on a number of not-for-profit boards including United States Energy Association, Bryce Harlow Foundation and Jefferson Islands Club. Harbert is a member of The Economic Club of Washington D.C.

Harbert is the former assistant secretary for policy and international affairs at the U.S. Department of Energy (DOE). She was the primary policy adviser to the secretary of energy and to the department on domestic and international energy issues. She negotiated and managed bilateral and multilateral agreements with other countries and also served as vice chairman of the International Energy Agency, which advises its 28 member nations on energy policy issues and orchestrates international responses to energy supply disruptions.

Prior to joining the DOE, Harbert was deputy assistant administrator for Latin America and the Caribbean at the U.S. Agency for International Development (USAID). She had oversight of programs in 11 countries, totaling more than \$800 million and 1,000 employees. In the private sector, Harbert worked for over a decade developing international infrastructure and power projects valued at more than \$9 billion in countries in the Middle East, Asia, and Latin America.

Harbert gained experience on issues associated with economic reform and privatization through earlier positions at the USAID, the Organization of American States, and the International Republican Institute. She received a degree in international policy studies and political science from Rice University in Houston, Texas.

Harbert resides in Washington, D.C.



Abby Smith, President & CEO, Team PA Abby Smith is President & CEO at Team Pennsylvania Foundation, a nonprofit, nonpartisan, statewide organization dedicated to accelerating the commonwealth's economic growth through public-private partnership. Among other initiatives, Team Pennsylvania hosts the Pennsylvania Energy Horizons Cross-Sector Collaborative, an action-oriented, statewide public-private network that brings together leaders from industry, labor, government, nonprofits, and academia to unleash innovative, technological, and market-driven solutions to reduce emissions economy-wide while expanding the Commonwealth's clean energy economy. Currently, the Collaborative's work is focused on two strategies that promote decarbonization: 1) carbon capture, utilization and storage (CCUS) and hydrogen deployment, and 2) advanced nuclear.

Formerly the Vice President of Policy & Programs and Senior Advisor to the Foundation, Abby's 20-year career includes high-level strategic planning and leading cross-sector collaboratives at the state level in Pennsylvania as well as in several other states. Abby has ample experience as a grant and project manager overseeing multimillion dollar grants, serving on various state-level councils, and leading multiple public-private partnership efforts. Before serving as Vice President, Abby was the Director of Education & Workforce Development at the Foundation.

Prior to joining Team Pennsylvania in 2013, Abby worked as a policy specialist at the PA Department of Education; for Teach For America as a recruitment director; and as a 7th grade social studies teacher and Teach For America corps member. Abby attended Yale University and has master's degrees in teaching from The Johns Hopkins University and in public policy and management from Carnegie Mellon University. She serves as the Chair of the Board of Directors of the Jewish Federation of Greater Harrisburg and JCC and is a board member of the Jewish Community Foundation of Central PA. As Chair of the Federation, Abby spearheaded the acquisition of a new Jewish community campus - the Alexander Grass Campus for Jewish Life - set to open in Fall 2023. Abby lives in Harrisburg, PA with her husband, twin 12-year-old sons, and her dog Comet.



Shawn Bennett, Energy and Resilience Division Manager at Battelle, where he oversees all governmentfunded energy projects awarded to Battelle. In this role, he primarily focuses on opportunities in Carbon Capture and Storage, Hydrogen, Rare Earth Elements and Critical Minerals, and Direct Air Capture. Mr. Bennett is a former Managing Director at FTI Consulting in their Energy and Natural Resources sector. Mr. Bennett is also the former Deputy Assistant Secretary for the Office of Oil and Natural Gas at the U.S. Department of Energy, where he oversaw the Department's research and development in the oil and gas sector, policy analysis, methane quantification and mitigation, and regulated LNG export authorizations for the United States.



Lisa Bruderly, Shareholder, Babst Calland, Attorneys At Law

Lisa is a shareholder and past chair of the Environmental Group of Babst Calland. She is also a member of the Firm's Energy and Natural Resources Group. Ms. Bruderly primarily focuses on regulatory compliance issues associated with water resources, including the management of wastewater, stormwater, drinking water, and sewage, as well as the permitting and mitigation of impacts to streams and wetlands. Ms. Bruderly represents clients in negotiating federal and state enforcement actions, including civil penalty assessments and consent decrees. In 2021, Chris partnered with Harris County officials in Houston to expand an extensive state-of-the-art air monitoring system to continuously track and evaluate air quality. The partnership included a \$1 million donation from ACC's foundation for mobile and stationary monitors. In 2020, Chris spearheaded ACC's role as a founding partner of the Future of STEM Scholars Initiative (FOSSI), which provides scholarships for students pursuing STEM degrees at Historically Black Colleges and Universities (HBCUs). Chris received the AIChE "Doing a World of Good Medal" and the CME STEM Leadership Award™ for his commitment to supporting a skilled, diverse workforce. Also in 2020, Chris oversaw a strategic review of Responsible Care®, the chemical industry's environmental, health, safety and security (EHS&S) performance initiative, resulting in enhancements to the Responsible Care Process Safety Code and Responsible Care Security Code. Prior to joining ACC in 2019, Chris served as President and CEO of The Fertilizer Institute, president of the National Association of Chemical Distributors, and president of the Contract Services Association. He began his career on Capitol Hill, including time as chief of staff to U.S. Senator Craig Thomas (R-WY). Chris earned an MBA from the University of Maryland and holds a bachelor's degree in political science from Columbia University in New York.
