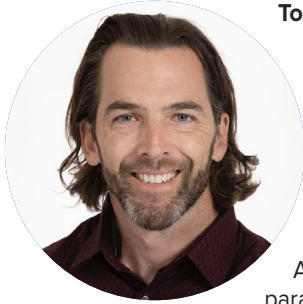

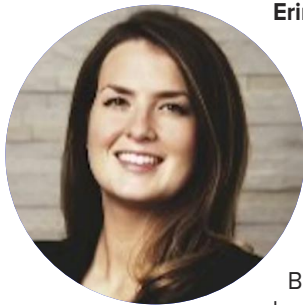


Neal Leshner, Director of Government Affairs, PA Chamber

Patricia “Patti” Jackson-Gehris is market president of UPMC North Central Pa. and president of UPMC Williamsport. Patti is responsible for the overall management of UPMC’s facilities that provide essential services to some of the state’s most rural communities, which include UPMC Williamsport, a Level II Trauma Center, and three critical access hospitals – UPMC Muncy, UPMC Wellsboro, and UPMC Cole (Coudersport), and dozens of outpatient clinics and centers including UPMC Hillman Cancer Centers in Williamsport and Wellsboro and Pennsylvania’s only Outpatient Emergency Department in Lock Haven.

Patti has worked in health care for over 30 years. She joined UPMC in 2015, then Susquehanna Health, and served as vice president of Market Development and Communications and then vice president of Strategy and Business Development before being named chief operating officer of UPMC North Central Pa. and president of UPMC Williamsport. Rep. Arvind Venkat, PA House of Representatives District 30

Rep. Arvind Venkat, an emergency physician, was elected to serve his first term in the state House of Representatives in November 2022. He is the first Indian American to be elected to the state House and the first physician to serve in the General Assembly in nearly 60 years.

He serves as State Representative for the 30th Legislative District, which includes part of Hampton Township, and all of McCandless, Franklin Park, Ohio Township, Emsworth, Ben Avon, Ben Avon Heights, and Kilbuck.

Rep. Venkat is a fighter for accessible and affordable healthcare, investing in our first responders, protecting reproductive rights, curbing gun violence, expanding access to the ballot box for all voters, and getting more people back into the workforce.

His parents immigrated to the United States, and it was their hard work and commitment to service that inspired him to become a physician.

Rep. Venkat completed his undergraduate and graduate education at Harvard University, his medical education at Yale University, and his emergency medicine residency at the University of Cincinnati/University Hospital. He served as a member of the Board of the McCandless-Franklin Park Ambulance Authority and is a former president of the state emergency physicians organization.

Rep. Venkat currently lives in McCandless with his wife and three children.

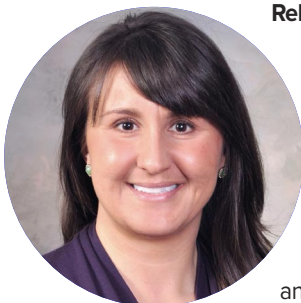
Secretary Valerie Arkoosh, MD, MPH, Department of Human Services

Valerie A. Arkoosh, MD, MPH, was appointed to lead the Pennsylvania Department of Human Services by Governor Josh Shapiro on January 17, 2023.

Secretary Arkoosh leads a team of 16,000 who serve approximately 4 million Pennsylvanians through programs including Medicaid, CHIP, SNAP, Early Intervention and Child Care Works, and services that address the needs of individuals with intellectual, developmental, and physical disabilities as well as child welfare and juvenile justice programs. Secretary Arkoosh focuses on embedding a whole-person, proactive, and preventive approach to service and care delivery, building supports and interventions that help Pennsylvanians achieve greater stability and better health.

Prior to state service, Secretary Arkoosh was elected to and served on the Montgomery County Board of Commissioners for eight years and was elected by her colleagues to serve as Commission Chair from November 2016 through January 2023, the first woman ever to serve as Chair.

Arkoosh is a graduate of the University of Nebraska College of Medicine, received a Master of Public Health from the Johns Hopkins Bloomberg School of Public Health, and holds a B.A. in economics from Northwestern University. She performed her residency at Jefferson Medical College in Anesthesiology with a special focus in Obstetrics.

Joe Glinka, Director, HealthChoices, Highmark Wholecare

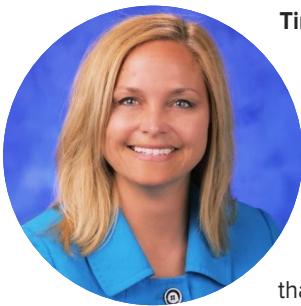

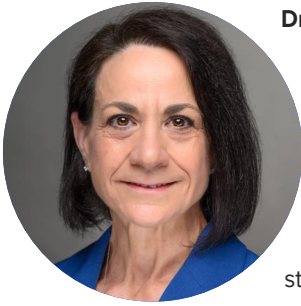
Susan Biggs, Executive Director, Healthcare Education, HACC, Central Pennsylvania's Community College
