Kelly McManus, Executive Vice President of Education, Arnold Ventures

Kelly McManus leads Arnold Ventures' education team, driving efforts to increase the return on investment in the education system for both students and taxpayers. Under her leadership, Penn State has achieved a balanced budget a year ahead of schedule, completed its most successful fundraising year ever in 2024-25, and reached new heights in research, intellectual property, and external engagement. She has accelerated interdisciplinary research, continued to build Penn State as a national leader in public impact and innovation, and initiated a multi-year reimagining of the Commonwealth Campus structure.

President Bendapudi previously served as president of the University of Louisville and held senior academic roles at the University of Kansas and The Ohio State University. She holds a Ph.D. in marketing from the University of Kansas, and her research on consumer behavior has appeared in top academic and professional journals.

In this role, she works closely with business leaders, legislators, educators, and industry partners to ensure community colleges are responsive to evolving workforce needs and help employers build the talent pipeline they require.

With more than three decades of leadership experience in higher education, Dr. Stanley has served as a college president, vice chancellor, associate vice chancellor, and executive leader at institutions across the country. Throughout her career, she has championed innovative workforce training, industry partnerships, student access initiatives, and strategic investments in technology to improve organizational effectiveness and student outcomes. He was a staff attorney in the Mass Media Bureau during President George Bush's administration. He has extensive work experience in the entertainment area of business, working with law firms as well as Time Warner. He spent 14 years working at Time Warner's corporate office across its cable, movie, and music divisions.

Also in the private sector, Dr. Williams worked as an economic policy analyst for a consulting firm and as an investment advisor for a regional investment firm in Washington, D.C.

He has written several workbooks on e-commerce law, project management, and Internet marketing, and has published over 75 articles on various business topics. As a public official, he has written and presented several documents on various topics relating to free trade and free trade agreements.

He earned his bachelor's degree in economics and finance from Howard University; his MBA from Wake Forest University; and his JD from Wake Forest University, along with certifications and executive leadership studies at Catholic University of America and Harvard University.

He previously served as the Chief Resilience Officer and Assistant Director for the City of Pittsburgh's Department of City Planning and Department of Innovation and Performance and Department of Innovation and Performance. His accomplishments include the development of Hays Woods into Pittsburgh's newest park, the catalyst for the Uptown Eco Innovation District which as spurred over \$500 million in infrastructure and construction activities, the ONEPGH resilience strategy and public private partnership platform, The Pittsburgh Climate Action Plan and the Western Pennsylvania Energy Consortium Renewable Energy Procurement Program among many other initiatives. Mr. Ervin's activities led to the City's participation in number national and global partnerships with the Rockefeller Foundation, Robert Wood Johnson Foundation, and Bloomberg Philanthropies, which connected his hometown of Pittsburgh with the world.

Ervin currently serves as a Fellow of the Royal Society of Arts (FRSA) Manufactures and Commerce, on the Green Builders Committee of the Master Builders of Western Pennsylvania, the transportation policy advisory committees of the Associated Pennsylvania Constructors, Pennsylvania Chamber of Business and Industry, as an advisor to Pittsburgh Earth Day – where he hosts the monthly Green Voice Podcast, and on the board of directors of CONNECT (the Congress of Neighboring Communities), The Pennsylvania Economy League, Pittsburgh Parks Conservancy and The Challenge Program.

Ervin continues to advise cities and local governments on matters of sustainability and infrastructure. He holds a Master of Public and International Affairs (MPIA) with a specialization in Global Political Economy from the University of Pittsburgh – Graduate School of Public and International Affairs, a BA from Washington and Jefferson College, and his Environmental Social and Governance Executive Certificate through Wharton Executive Education at the University of Pennsylvania.



Anthony (Tony) Crerand, MBA, FACHE, Associate Chief Human Resources Officer, Penn Medicine Lancaster General Health

Anthony (Tony) Crerand, MBA, FACHE, is Associate Chief Human Resources Officer at Penn Medicine Lancaster General Health and has been employed by the organization since 2017.

In his current role, Tony provides executive leadership and strategic oversight for all Human Resources functionality, partnering closely with his senior team to align workforce strategy with organizational priorities to support LGH's nearly 10,000 employees. In addition to his role with Penn Medicine Lancaster General Health, Tony is also an adjunct professor in the Executive MBA Program at Lebanon Valley College most recently teaching Ethical, Legal and Policy Issues in Healthcare Management.

Prior to serving in Human Resources leadership, Tony held progressive operational leadership roles within Penn Medicine Lancaster General Health, including Regional Director of Operations, where he oversaw primary care practices, regional outpatient centers, and virtual care services. Earlier in his career, he served in leadership roles with WellSpan Medical Group and Family Health Associates, leading multi-site healthcare operations and large interdisciplinary teams.

Tony holds a Bachelor of Science in Business from Saint Joseph's University and a Master of Business Administration from York College of Pennsylvania. He is a Fellow of the American College of Healthcare Executives (FACHE) and is also actively engaged in several professional and community service organizations throughout the South Central Pennsylvania region.



Christopher M. Fiorentino, Ph.D., Chancellor, Pennsylvania's State System of Higher Education (PASSHE)

Dr. Fiorentino was named the sixth chancellor of PASSHE in 2025, leading the system of 10 state universities that serve more than 80,000 students. Dr. Fiorentino is an educator and economist who served as president of West Chester University (WCU) from 2017 to 2024 and retired from that role having served the university for 41 years, starting as an assistant professor of economics in 1983.

Prior to being named president of WCU, Dr. Fiorentino served as interim president for one year and vice president for external operations for three years. He previously spent nearly 20 years as dean of WCU's College of Business and Public Affairs (now the College of Business and Public Management); his tenure within the Department of Economics included four years as chair.

As president of the largest university in PASSHE, Dr. Fiorentino led the university through a global pandemic and provided valuable thought-partnership to his fellow presidents and system leaders amid the nationwide demographic shift as the number of high-school graduates declined.

Throughout his leadership, Dr. Fiorentino — who was named to Philadelphia Business Journal's Power 100 list in 2021, 2022 and 2023 — instilled a spirit of innovation and ownership that has empowered students, faculty, and staff. Just prior to his retirement, he was inducted into the Chester County Hall of Fame by the Chester County Economic Development Council (CCEDC). The Board of Governors conferred the status of President Emeritus upon Dr. Fiorentino in the summer of 2024, and he was awarded an honorary doctorate for public service by Bucks County Community College, which he attended prior to transferring to Temple University.

Committed to propelling the university forward, Dr. Fiorentino oversaw the construction of the largest building project on the university's campus — the 175,000-square-foot Sciences & Engineering Center and The Commons.

Early on, Dr. Fiorentino helped WCU fulfill its mission to serve local communities and the Commonwealth as a source of knowledge and skill development, a research center, and a service provider. As dean, he helped to secure AACSB accreditation for the School of Business; developed off-campus academic centers, including the Graduate Center in West Goshen Township; and worked with faculty and supporters to create the Cottrell Entrepreneurial Leadership Center. Dr. Fiorentino also spearheaded the development of the Center for Community Solutions, which links business and civic leaders who have research needs with university faculty and staff who can address those needs.

Dr. Fiorentino earned his baccalaureate, master's, and Ph.D. degrees in economics from Temple University. He and his wife Sue reside in Chester County, PA.



Tom Foley, President, Association of Independent Colleges and Universities of Pennsylvania

Thomas P. Foley has worked in senior leadership positions in both workforce development and higher education. He led Pennsylvania's job training programs as the Commonwealth's Secretary of Labor and Industry, and spent another decade as President of an independent nonprofit college, where 90 percent of the students were in career-focused majors at a liberal arts-based institution. He currently serves as President of the Association of Independent Colleges and Universities of Pennsylvania (AICUP), representing more than 80 independent nonprofit schools that educate more than half of PA's post-secondary students. He has authored dozens of articles on education and the workforce and has testified on these topics more than 40 times before state and federal legislative bodies.

Foley's deep commitment to public and community service includes two years as a volunteer in Belfast, Northern Ireland, and more than a decade as President and CEO of the Commonwealth's two largest volunteer-based nonprofits - the United Way of Pennsylvania and Red Cross (of Southeastern Pennsylvania). Foley is a first-generation college graduate, thanks to scholarships from Dartmouth College, University College Dublin, and Yale Law School. His wife, Michele, has taught English and Spanish at the elementary, middle, high school, and college levels over a 30-year career.



Kate Gallagher, Vice President of Impact, Rock Global

Kate Gallagher is Vice President of Impact for Rock Global. She brings more than two decades of experience to her role, with skills in strategic planning, operations, organizational development, and mission-driven leadership.

Throughout her career, Kate has helped purpose-driven organizations turn ambitious ideas into clear strategies, aligned action, and measurable, lasting outcomes. Her work is grounded in collaboration, lived experience, and a commitment to expanding opportunity, strengthening education-to-workforce connections, and advancing economic mobility for students and communities.

Kate holds a Master of Nonprofit Management from Regis University and a bachelor's degree in Human Development and Family Studies from Penn State University.



Representative Peter G. Schweyer, Chairman, House Education Committee

Representative Peter G. Schweyer was first elected as State Representative in 2014, representing Lehigh County. He currently serves as Majority Chairperson of the House Education Committee, where he led the fight to create a fairer system of funding public schools in the Commonwealth.

This work earned the praise of Governor Josh Shapiro, who at a bill signing ceremony in his district, said this about Schweyer, "Democrats, Republicans, House members, Senate members, people inside government, and people outside government. And we came up with a plan through a commission led by Chairman Schweyer, and then ultimately through legislation."

In his role as Education Chair, Schweyer also crafted the biggest change to Pennsylvania's system of higher education in nearly four decades, creating new scholarships and immediate new pathways to higher education while helping to control the cost of higher education in the long term through the creation of the State Board of Higher Education.

In addition to his work in education policy, Peter has authored legislation that has helped the Lehigh Valley's craft beer, wine, and spirits industry grow, has fought to protect our community from gun violence, and has been a leader on renewable energy, specifically community solar. Lastly, having been appointed as a member of the bipartisan medical marijuana policy work group, he crafted Pennsylvania's medical marijuana law.

Schweyer served for nearly six years as a member of Allentown City Council, including a stint as Council President. His accomplishments there include reforming the city's finances and pension, creating a highly successful gun buyback program, and crafting the city's comprehensive anti-graffiti law.

Schweyer serves as a member of the PA Higher Education Assistance Agency (PHEAA) and the PA State Board of Education. He has been appointed as a member of the National Conference of State Legislatures' Higher Education Task Force and is a member of the national group Education Commission of the States.

Lastly, Speaker Joanna McClinton also appointed Schweyer as Chair of the PA State House Ethics Committee.

He has received numerous awards from the PA School Boards' Association, Penn State, the Literacy Center, Lehigh Valley Labor Council, and the PA Beer Alliance, to name a few. He was named a Trailblazer in Higher Education in 2024 by City and State Magazine and was named a 20 Under 40 by the East Penn Business Journal (now known as Lehigh Valley Business) in 2011.

He and his wife, Jennifer, have been married since 2005 and live in the same South Allentown home that they purchased a few months after they were married. They have two wonderful daughters, Sarah and Erin, both products of the Allentown Public School District. Sarah, a recent ASD graduate, attends Penn State, while Erin is in high school.

Peter attended Cathedral of St. Catherine of Sienna (Now St. John Vianney) and graduated from Allentown Central Catholic High School. He then graduated from Penn State University with an Honors Degree in Political Science.

Schweyer is an avid Penn State Football fan, and (randomly) is a lifelong Chicago Cubs fan. His hobbies include playing guitar, boating on the Lehigh River, and cooking. Senator Dave Argall represents 102 municipalities in northeastern Pennsylvania's Schuylkill and Carbon Counties and part of Luzerne County including the city of Hazleton.



Senator David Argall, Chairman, Senate Policy Committee

As a member of the Senate's majority leadership team, Chairman of its Senate Majority Policy Committee, and the proud grandson of Cornish, Welsh, and German farmers, coal miners, and factory workers, Senator Argall's top priority is revitalizing our older industrial communities.

Growing up, he witnessed first-hand the devastating impact of job losses in manufacturing and mining. Because of his grassroots teamwork, blighted communities have witnessed a positive transformation.

He chaired a bipartisan commission which unanimously recommended more than \$400 million in savings and is a leader in conservation and abandoned mine reclamation initiatives, locally as a volunteer Scout leader and as the author of legislation which has recycled more than 97 percent of Pennsylvania's waste tires.

Senator Argall earned a bachelor's degree from Lycoming College and a Ph.D. from Penn State. His studies included the economic and political transformations in Germany after the fall of the Berlin Wall and the benefits and drawbacks of Pennsylvania's tax-free "Keystone Opportunity Zones."

Dr. Argall has served as a part-time public policy instructor for more than 30 years at Lycoming College, Penn State, and at Lehigh Carbon Community College, where he helped to lead the transformation of the junior high school where his parents once taught into LCCC's Morgan Center.

Senator Argall and his wife Beth are the proud parents of AJ and Elise, who are pursuing careers in patent law and communications and the grandparents of Amelia and Charlie.



Dwayne Lee Pinkney, Executive Senior Vice Chancellor for Administration and Finance and Chief Financial Officer, University of Pittsburgh

Dwayne Lee Pinkney is the University of Pittsburgh's executive senior vice chancellor for administration and finance and chief financial officer.

Pinkney serves as a key adviser to Chancellor Joan Gabel and the senior leadership team on financial objectives and policies. From student housing, dining and campus safety, to the budget, student payments, purchasing and payroll, Pinkney leads a team of 1,400 staff members who provide foundational support and strategically use resources to further the University's mission and strategic plan, the Plan for Pitt 2028.

Pinkney brings decades of experience in a range of fiscal and operational roles, combining expert knowledge and strategic focus. He holds a long-standing commitment to students and shared governance; is well versed in collaborating with governance boards, presenting executive-level financial and operational data to internal and external stakeholders; and has a robust track record of effective advocacy and experience with capital construction planning, strategy and execution.

An alum of Pitt's School of Public and International Affairs, Pinkney (SPIA '87G) returned to Pitt after serving as the inaugural executive vice president for finance and administration at Indiana University, where he was responsible for leading the finance and administration organization. Prior to his time at IU, he served as senior vice president and chief business officer at Virginia Tech and as chief financial officer and senior associate vice chancellor for finance and administration at the University of North Carolina at Chapel Hill. He began his career in the North Carolina General Assembly as an analyst and served as the deputy secretary for administration with the North Carolina Department of the Secretary of State.

Pinkney serves on the board of the UPMC Health Plan and on the NCAA Investment Subcommittee of the Finance and Audit Committee, which focuses on financial investment strategies.

In addition to a master's degree in public administration from Pitt, Pinkney holds a Ph.D. in political science from the University of North Carolina-Chapel Hill and a bachelor's degree in English and journalism from North Carolina A&T State University.
